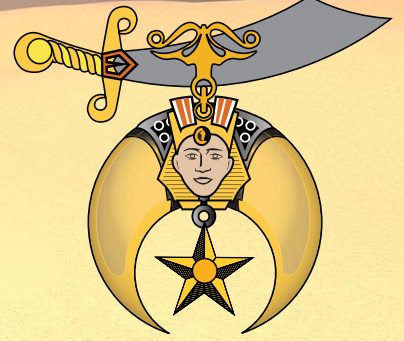

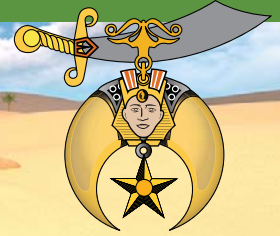

THE FEZ

We all know that Shriners began with thirteen Master Masons, who met regularly at the Knickerbocker Cottage in New York City in 1870. These Master Masons decided to create a new fraternity that combined the tenets of Freemasonry with elements of fun and fellowship. Little did they know that they were laying the foundation for a worldwide fraternity which established a globally recognized pediatric specialty health care system.

One of the original thirteen Master Masons, Mr. Billy Florence had been on a tour in Europe, while there he attended a party given by an Arabian diplomat. He was impressed with the exotic style, flavors and music of the Arabian-themed party. As a result, he suggested to the group that they adopt an Arabian theme for use in the new fraternity.

These thirteen Masons drafted the ritual, designed the emblem and costumes, formulated a salutation and declared members would wear the red fez with a black tassel. The red fez with the black tassel is one of the fraternity's distinctive symbols which pays homage to the Middle Eastern origins of the fraternity and honors their Masonic roots.

Adorned with various symbols and emblems, the fez serves as a visual representation of our organization's identity and principles. Each fez is personalized for the noble who wears it, indicating what Shrine Center they belong to and what position he holds.

The crescent and scimitar, the emblem on the front of the fez, is an important part of the fraternity's theme and is representative of the characteristics embodied by Shriners.

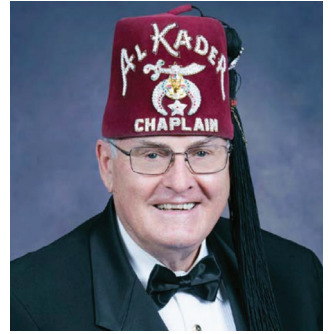
The scimitar represents the members who are the backbone of the fraternity. The two claws represent the nobility of the fraternity and its philanthropy Shriners Children's. The sphinx stands for the governing body of Shriners. The five-pointed star represents the thousands of children helped by our philanthropy each year. The theme which was adopted to accompany this emblem is "Robur et Furor," which in Latin means "strength and fury."

Each time I hear Noble Matt Alexander recite the poem, "My Old Red Fez" a warm joyful feeling comes over me. It reminds me of how proud I am to be a Shriner and grateful I am to live in America.

As Shriners we are encouraged to wear our fez in public frequently, this encouragement has come from the Imperial Potentates as well as IS Martin Bush our potentate, and several previous potentates of Al Kader. ***So, Nobles wear your fez with pride!***

It is usually preferable to do some communications and planning to prevent a judge, court or the IRS deciding distribution of your assets.

Enough on this topic. We have a lot going on in our Lodges and at Al Kader. It is great to be coming back in person again in growing numbers with our Brothers, Nobles and our Ladies. Reignite the excitement and passion of when you were fezzed. We are after all a fraternal organization that has fun with a purpose.

Fundraising Policies and Procedures... What You Need To Know.

It seems that this is the time of year that the majority of our clubs and units start thinking and planning a fundraiser. Did you realize that fundraising is regulated by Shriners International? I think that sometimes we get so enthused and excited by these activities we just move forward.

It is natural for everyone to associate the "Fez" with Shriners Children's Hospital because Shriners have been and continue to be the driving force behind Shriners Children's. What is not understood or recognized by the general public and some Shriners is that there are two separate and distinct legal corporations.

Shriners Hospitals for Children is a 501(c)(3) incorporated in the state of Colorado and it operates the hospital system, which is a charitable corporation. A charitable fundraiser is where 100% of the net proceeds benefit Shriners Hospitals for Children.

Shriners International is incorporated in the state of Iowa and it is the fraternal corporation, that regulates all of the various Shrine Temples. A fraternal fundraiser is where the net proceeds benefit the local Temple, Club or Unit.

The Potentate shall exercise general supervision over the Temple and is responsible to the Imperial Council for all activities within the Temple. All fundraisers require written permission of the Potentate each year before engaging in the activity. There is a notification form that must be submitted to Al Kader. Contact the office at Al Kader to obtain a copy of this form. Charitable fundraisers require the permission of the Imperial Potentate before engaging in the activity. Our recorder assists with this process and is a good source of information. Shriners International has published a brochure entitled "Fundraising Policies and Procedures," which is available at Al Kader.

All fundraising must comply with all federal, state and local laws. The fundraising promotions must include a statement indicating the entity to receive the benefit of the fundraiser.

A detailed financial record of all revenues and expenditures relating to the fundraiser must be reported to Al Kader Shrine Center and be maintained for a period of seven years.

A statement of purpose must be included on all promotional material. Fraternal fundraisers would indicate: "Net proceeds from the (activity/event) are for the benefit of Al Kader Shrine Center or Unit or Shrine Club name and are not tax deductible. Charitable fundraisers would indicate: "Net proceeds are for the benefit of Shriners Children's Hospital, are tax deductible." It is important that we do not use copyrighted logos, such as the one for the hospital. The Shriners International web page has various authorized logos that can be used.

In the state of Oregon all raffles are regulated by the Department of Justice. These regulations/rules must be followed so as not to jeopardize Al Kader's gaming license. It is not difficult to obtain permission from DOJ to conduct a raffle we just need to follow the proper steps. I was unaware of these regulations until this year, when preparing for the raffle of the Harley Davidson Motorcycle. The by-laws of Shriners International indicate that the integrity of our charity and of our fraternity must remain above reproach. If these rules are not followed then the Club/Unit/Temple conducting the fundraiser risks the loss of all funds raised, to include the funds associated with the event (seed money).

In no way or manner am I attempting to discourage our clubs or units from conducting fundraisers, they are necessary. I am positive that there are many fraternal fundraising activities that go on each year within Al Kader, each of them is important to the club/unit that do them. My intention is to encourage each of us to do this important activity in the proper manner.

Recently the band had a Saturday work party to spruce-up the band wagon, checking the running gear, touching up the paint, kicking the tires, etc.



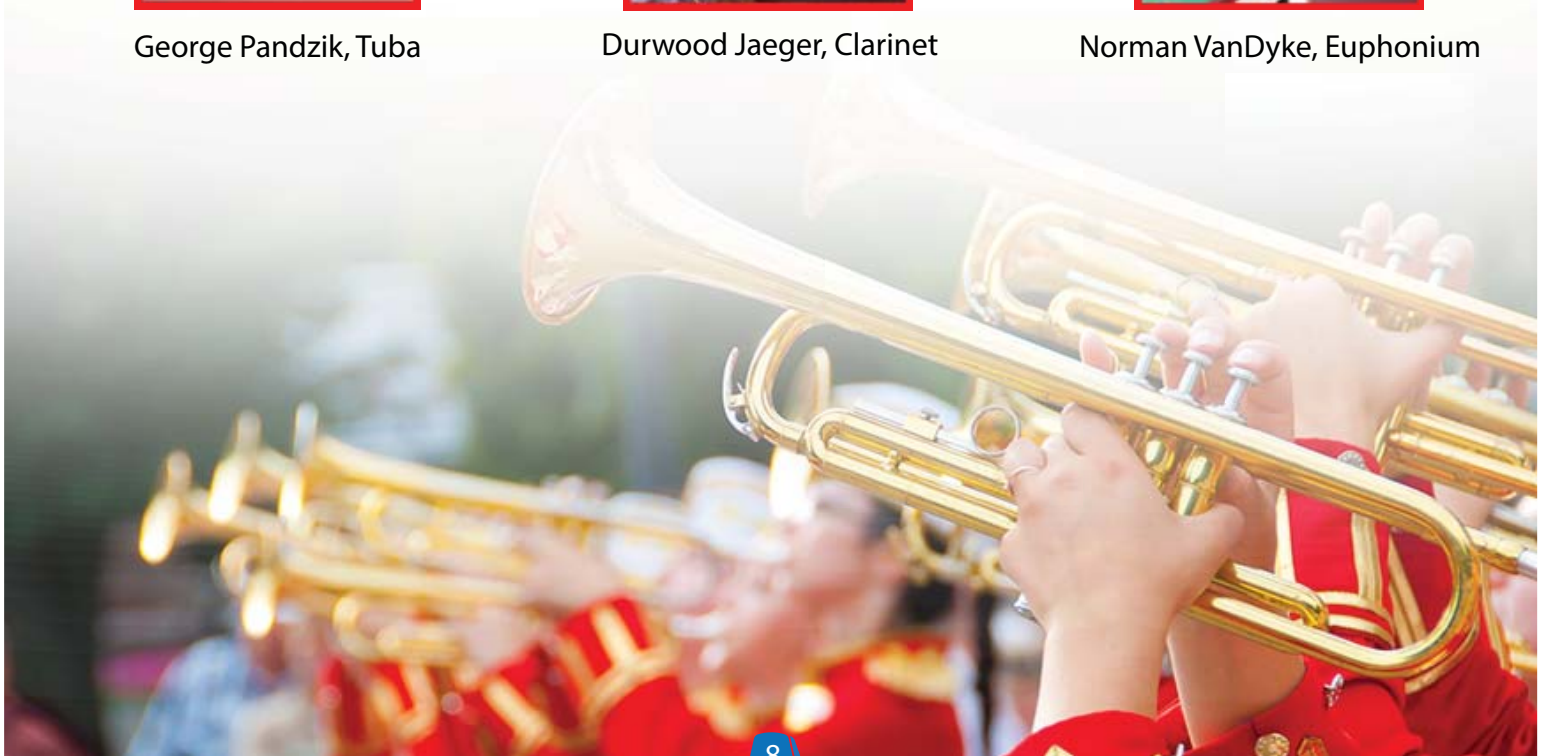
